NOTICE OF PENDING ORDINANCE

The Bond Ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the Borough Council of the Borough of Rutherford, in the County of Bergen, State of New Jersey, on April 13, 2026. It will be further considered for final passage after public hearing thereon at a meeting of the governing body to be held at the Borough Council at the Municipal Building, 176 Park Avenue, Rutherford, New Jersey in said Borough on April 27, 2026 at 6:30 p.m. During the week prior to and up to and including the date of such meeting, copies of the full ordinance will be available at no cost and during regular business hours, at the Clerk's Office for the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

Title: Bond Ordinance Authorizing Various Capital Improvements In And For The Borough of Rutherford, In The County Of Bergen, New Jersey, Appropriating \$1,800,000 Therefore And Authorizing The Issuance Of \$1,710,000 Bonds Or Notes To Finance Part Of The Cost Thereof.

Purpose(s): Providing for various street and road improvements, including but not limited to Darwin Avenue, Hastings Avenue, Wingra Avenue, Morse Avenue, Montross Avenue and Transit Village, including road surfacing, underlying storm culvert renovations, underlying sanitary sewer renovations and sidewalk renovations; Providing for improvements to buildings and grounds, including but not limited to, Borough Hall flooring, Borough-Wide building and grounds improvements; Providing for improvements to Parks and Playgrounds, including but not limited to new concrete sidewalks/walkways at Van Winkle Park, Tryon Playground, Memorial Field and Tamblyn Field, landscape and aesthetic improvements at Tamblyn Field and multipurpose turf field and lights at Memorial Field; Acquisition of vehicles, including but not limited to, Police Department patrol sport utility vehicle and a pick-up truck with liftgate for the Department of Public Works; and Acquisition of non-vehicular equipment, including but not limited to, Borough wide computer system upgrades, parking meter replacement program, skid steer wheel loader and firefighting equipment for the Fire Department.
